**CORRIGENDUM**

The Central Electricity Regulatory Commission had issued order dated 30.8.2018 approving slab rates for PoC Charges towards 'LTA/MTOA and STOA', Reliability Support Charge Rate, HVDC Charge Rate as well as slabs for PoC losses for the Application Period July – September, 2018.

2. It has come to our notice that an error in the calculation of PoC Slabs rate has crept in with regard to the yearly transmission charges of Chhattisgarh WR Transmission Limited which was not considered in calculation of PoC Slab Rates for July – September, 2018 by the Implementing Agency i.e the respondent, NLDC.

3. Accordingly, table in Para 6 (a) , table in Para 6 (b), Annexure- II and Annexure- III of the order dated 30.8.2018 in which PoC slabs Rates and Reliability Support Charges Rates for LTA/MTOA and STOA billing have been revised. HVDC charges rate shall continue to be charged as per order dated 30.8.2018. The revised Annexure-II and Annexure- III is annexed with this order.
