Regulation of power supply was imposed by NEEPCO on MePDCL which was effected from 00:00 hrs on 03.01.2019 from all power stations of NEEPCO for 6 months. Vide letter no: NEEPCO/ED/Comml/R-16/2018-19/1288 dt. 21.02.2019(enclosed) NEEPCO has desired to partially withdraw regulation wef 26.02.2019 to 02.03.2019 from all power stations with the following exception.

Regulation would continue from AGBPP and AGTCCP from 1630 hrs to 2200 hrs for 34.38 and 16.58 MW respectively during the said period.


Subsequent to this, full regulation would continue wef 0000 hrs of 03.03.2019.

Sir,

In view of the request made by Power Department, Government of Meghalaya for withdrawing the regulation of power supply for the ensuing District Council Election'2019 for two Autonomous District Councils in the state of Meghalaya & considering their request for temporarily withdrawal of regulation to avoid the ongoing load shedding during the election process, we hereby withdraw partially regulation of power supply to MePDCL, Meghalaya as follows:


- A. 100 % withdrawal of Regulation w.e.f 00.00 hours of 26.02.2019 to 02.03.2019 from all NEEPCO power stations except AGBPP & AGTCCP.
B. However regulation will be continued from AGBPP & AGTCCP during the peak hours as follows:
